2. A confirmation letter will be sent out as soon as you are accepted, if no confirmation is received applications along with your check will be returned
3. A late fee of \$100.00 will be charged for payments after March 5th, 2006 (Strictly Enforced)
4. There will be no requests for **exclusive** of any products.
  - *Vizzun Entertainment Inc. reserves the right to allow any exclusive of any product.*
5. *Food Vendors* are required to obtain and pay for any health permits required by the State of Nevada or Clark County. Please make contact with The State of Nevada as soon as you are accepted. Ph. (702) 229 6281
6. Vizzun Inc. will not be responsible for any vendors that get shut down due to lack of permits and health requirements.
7. Vizzun Ent. Inc. will pay and obtain temporary business license for Food, Craft, and Info. booths.
8. Vizzun Entertainment Inc. will provide (1) 20 amp electrical outlets for each purchased 10' x 10' **Food Booth**.
9. Absolutely No Beverages and alcohol of any type shall be sold from any booth (vendors will be shut down with no refunds if this policy is broken).
10. There will be absolutely no subleasing of the booths.
11. Security will be provided on the premises for Friday and Saturday night, vendors are required to lock up any merchandise that is of value, for Vizzun Entertainment Inc. is not responsible for lost or stolen items.
12. All booths must be in operational and staffed throughout the entire event. Closing of booth early is not allowed.
13. There will be no Wholesale Vendors allowed at this event!

7. Food Vendors are responsible for disposing any grease used in preparation.
