Retail Vendors: \$600 + \$50 Refundable Deposit

Retail Booth Purchase includes (One) 10' x 10' Canopy, (One) 20 amp electrical outlet, (One) 8' banquet table, and (Two) Chairs

Food Vendors \$850 + \$50 Refundable Deposit

(All food booths are stand alone booths with 8' between each food booth)

Booth Purchase includes (One) 10' x 10' Canopy, (One) 8' Banquet table, (Two) Chairs, and (One) 20 amp electrical outlet per 10' x 10' food booth.

Each Vendor is responsible to provide your own lights & extension cords.

A late fee of \$100 will be charged for payments received after Friday, September 11th, 2009 (Strictly Enforced)

1. Vendor's acceptance will be determined on your booth payment paid in full and a completed Vendor application. Payments may only be made by Cashiers Check or Money Order.
2. **Booth Placement** is determined on when your application and payment in full is received.
3. Festival Information packets will be sent out by September 10, 2009.
4. There will be no requests for **exclusive** of any products.
 - *Vizzun Entertainment Inc. reserves the right to allow any exclusive of any products.*
5. Only Vendors that **purchases a corner booth** are guaranteed a corner.
6. Absolutely **No Beverages of any type** shall be sold or given away from any vendor booth. *Silverton Casino has exclusive beverage sales.*
 - (Any Vendor caught breaking this rule will be shut down with no refunds and not be allowed to participate in any future Vizzun Entertainment events).
7. There will be absolutely **no subleasing** of booths.
8. No promotional or marketing material shall be distributed without prior approval from Vizzun Entertainment. Approved promotional & marketing material can only be distributed at or in front of your booth only.
9. Security will be provided in Festival grounds Friday and Saturday. Vendors are required to lock up any merchandise that is of value. Vizzun Entertainment & the Silverton Casino lodge are not responsible for lost or stolen items.
10. All booths must be operational and staffed throughout the entire event. Closing of your booth early is not allowed and will result in forfeiture of your deposit.
11. Each vendor is responsible for the tidiness & cleaning of their area.
12. Security will be on site to ensure a safe and enjoyable event.
13. Each vendor is responsible for knowing and following all the Rules and Regulations.

Information for (Food Vendors Only)

1. *Food Vendors* are required to obtain and pay for a “Special Event Food Handlers Permit” required by the Clark County Health District.
Please call them at: Ph. (702) 759-0588 as soon as you are accepted.
2. You are only confirmed **ONE** main food item per food booth. Ethnic foods are an exception. You are *advised to call* before sending in your payment to confirm your food item availability.
 - Vizzun Entertainment will use its own discretion on what is considered a duplicate food item.
 - Vizzun Entertainment reserves the right to make any exclusives of any food items.
3. List all food items you want to sell. Two weeks prior to start of the event you will be notified of which item weren’t chosen. *Only at that time you will be allowed to sell more than one item.*
4. Vizzun Entertainment will not allow any food vendors to sell duplicate food items at this event unless prior approval in made.
5. Food item confirmation will be determined by your *booth payment in full*.
6. Each food vendor is responsible for disposing of their own grease, cooking oil, and garbage.
7. Potable water is available on site.
 - All electrical items must be listed. You are only allowed (One) 20 amp outlet only per purchased food booth. Generators will be turned off Friday & Saturday @ 11pm every evening.
 - If you are going to be requiring more power than provided you must list all items and purchase it
8. Vizzun Entertainment will not be responsible for any **food vendors** that get shut down due to lack of permits and health requirements.

Requirements for Food Vendors

1. Food handler’s permit (have ready for Health Inspector)
2. Complete list of menu items with pricing
3. Water dispenser, anti bacterial soap, and a catch for dirty water.
4. Catch Basin for Washing is required.
5. *Non* Flammable drip pan for BBQ
6. Fire extinguisher is required for each food vendor.
