Rules & Regulations

- The competition is open to anyone 21 years of age or older unless authorized by Vizzun Entertainment and Aloha Kitchen & Bar.

- Groups will be scheduled on a first come; first serve basis. You will be contacted by phone for time and date of scheduled performance.
- All members of the group must check in with Vizzun Entertainment at least **60 minutes prior** to scheduled performance time. Cancellations for scheduled performances must be made at least **7 days** prior to performance. Any no shows will disqualify you from any future competitions.
- All bands must provide their own backline for their performance. Aloha Kitchen & Bar will provide the Sound system.
- Each band is required to perform for a total of 45 minutes. The first 30 minutes will be a (Freestyle) performance then the last 15 minute of your performance will be scored and judged.
- There will be two categories that will compete against each other during the qualifying competitions:
 1. Reggae, Island Reggae, Roots, Reggae Rock, & Ska
 2. Traditional, Contemporary, & IslandCategories are just defining the bands that will compete against each other on the same evening. The finals could have one or both of the categories competing for the Grand Prize.
- Each evening there will be two bands scheduled to Compete. The first group will start at 10pm and the second group will start at 11:15pm.

- Each band competing will be given a \$50 Food or Beverage Comp for Aloha Kitchen & Bar.
- Weekly entrants will be judged and announced on that evening. The winner of the evening performance will be scheduled to compete in the semi finals on week 9 (September 6th) or week 10 (September 13th)
- All contestants, by entering the contest, you are agreeing to unpaid performances in connection with the **Vizzun Showdown**.
- Vizzun Entertainment & Aloha Kitchen & Bar assume no responsibility for loss or damage to any equipment or personal effects of groups entering the Vizzun Showdown.
- All decisions of the judges shall be final and binding.
- All entrants agree to release their performance to Vizzun Entertainment for promotional purposes.

Scoring

Scoring will be based upon a 100 point system.

1. **20** Points for Vocal Ability
2. **20** Points for Stage Presence
3. **20** Points for Originality
4. **20** Amount of people your performance draws
5. **20** Crowd reaction to performance
